Thank you for allowing Educational Discovery Tours the opportunity to assist in planning your performing experience! We look forward to working with you and your students in organizing a memorable trip. Please read this Letter of Understanding carefully as it outlines all the specifics and inclusions of your trip. Please sign where indicated, keep one copy for your records and return the other signed copy to Educational Discovery Tours.

Your **6 Day Hawaii Performance Tour** is scheduled to depart on 4/1/2024 and return on 4/6/2024. Your program cost will be \$2,953.00 per student and \$3,313.00 per adult, based on a minimum of 35 paying travelers on each coach. Trip price is subject to change based on increases imposed by transportation vendors, or if group falls below their 'costed on' number of 35 paying travelers per bus.

Payment schedule is as follows (based on student cost): Deposit in the amount of \$150.00 due 4/21/2023; 8 monthly payments in the amount of \$324.83 due 5/21/2023, 7/1/2023, 8/1/2023, 9/1/2023, 10/1/2023, 11/1/2023, 12/1/2023, 1/1/2024, and final payment in the amount of \$204.36 due 2/1/2024. **Cancel for Any Reason (CFAR) travel protection is highly recommended**. Travelers may purchase from any provider of their choosing, or from *Travel Insured* during the online registration process.

Should a cancellation become necessary, please inform EDT immediately in writing and request a written confirmation of your cancellation. Upon receipt, EDT will follow industry procedures for any applicable refunds as outlined in the supplier's terms and subject to their review. If you are entitled to a refund, please note that the supplier is responsible for this refund, not EDT. Generally, airlines tickets, hotel reservations and other items provided for travel cannot be refunded if they are partially used.

In addition to any terms of our suppliers, the following is EDT's cancellation fee schedule. In order to process your cancellation, please be sure to submit your notice of cancellation in writing. <u>If notice of cancellation is received:</u>

- More than 60 days prior to departure your deposit is non-refundable.
- Between 45 and 60 days prior to departure 30% of the total trip cost is non refundable
- Between 15 and 44 days prior to departure 50% of the total trip cost is non refundable
- Less than 15 days prior to departure 100% of the total trip cost is non refundable

These fees do not include non-refundable items such as theatre tickets or other deposits we have paid on behalf of you or your child; these fees will be in addition to the fees listed above.
